20 above named defendant of the following criminal offenses:

21 Count 1

22 On or about January 9, 2018, in the County of San Luis Obispo, State of California, the
23 crime of Murder in violation of PC187(a), a Felony, was committed in that ROBERT
24 WILLIAM KOEHLER IV did unlawfully and with malice aforethought murder K.R.M., a
25 human being. It is further alleged that the aforesaid murder was committed willfully,
26 deliberately and with premeditation within the meaning of Penal Code section 189, a
27 violent felony pursuant to Penal Code section 667.5(c)(1) and a serious felony within the
28 meaning of Penal Code Section 1192.7(c)(1).

PC12022(b)(1): Spec Alleg-Use Of Deadly Weapon
